1. Terms of Settlement – payment in full within **thirty (30) days** of the end of the month following delivery.
2. The Company may determine and charge a monthly handling fee on overdue account statements at the rate of 1.5% per month. This handling fee is subject to 10% GST. **NO CREDIT** will be allowed on overdue accounts.
3. Credit Return Policy - where goods are to be returned to this company for replacement or credit, the following conditions apply:
 - (i) Goods must be returned in a saleable condition. (ie. original packaging)
 - (ii) Goods are returned freight prepaid. (unless supplied in error)
 - (iii) Original invoice number and date must be quoted.
 - (iv) The Buyer shall be liable for handling charges as follows:
 - Within 10 Days - Full Credit
 - Within 10-20 Days - Less 10% handling charge plus 10% GST
 - After 21 Days - NO CREDIT
 - (v) Goods made to order of “especially procured on Buy-In Basis”, workshop manuals, parts altered, damaged, painted, or fitted by the Buyer (except warranty items) will not be returnable to this Company.
 - (vi) Certain goods attract other penalty rates, than those listed above, due to restrictions applied by outside suppliers.
